



NEW CANCELLATION AND RESIGNATION REGULATIONS

Concerns drinktec 2021

As the Board of Management has decided, the following cancellation and withdrawal regulations are to apply to all Messe München GmbH trade fairs that begin before 30 June 2022.

Cancellation without Statement of Reason

In deviation from Clause A5 of the General Terms of Participation in drinktec, any exhibitor cancelling its participation in drinktec without being entitled to a right of withdrawal, and thus refusing to perform its rental agreement without offering a reason therefor, shall pay to Messe München GmbH – irrespective of whether the exhibition space for drinktec remains vacant, or Messe München GmbH may have put such exhibition space to a different use in the best possible manner – not the participation fee but merely, by way of compensation for the expenditure incurred by Messe München GmbH on account of such exhibitor's unjustified cancellation of its participation in drinktec, a lump-sum reimbursement of expenses at a rate of 25% of the participation fee.

Travel Restrictions Applicable to Exhibitor

An exhibitor will be entitled to a right of withdrawal in cases where statutory or regulatory provisions are in place according to which at any given point in time within a period of six weeks prior to the first day of drinktec, no one will be allowed to exit from the country or part of the country where such exhibitor has its domicile, or to enter Germany; or that anyone entering Germany from the country or part of the country where such exhibitor has its domicile, shall place herself/himself under quarantine immediately upon entry.

An exhibitor will also be entitled to a right of withdrawal in cases where statutory or regulatory provisions, unlimited in time or applicable at least until the day following the final day of drinktec, are in place prescribing that no one who has stayed at any time during the term of drinktec, including its assembly and dismantling periods, in Germany or the part of Germany where drinktec has been held, may exit from Germany or enter the country or part of the country where such exhibitor has its domicile, or that anyone who has stayed at any time during the term of drinktec, including its assembly and dismantling periods in Germany or the part of Germany where drinktec has been held, and who may be entering the country of part of the country where such exhibitor has its domicile, shall place herself/himself under quarantine immediately upon entry.

NEW CANCELATION AND RESIGNATION REGULATIONS

If drinktec 2021 is postponed for reasons of force majeure, such as an epidemic or pandemic, or for other reasons for which Messe München GmbH is not responsible, the contract already concluded shall continue to exist with its rights and obligations.

If drinktec 2021 is cancelled, the obligation to pay the participation fee shall not apply; participation fees already paid shall be refunded within 4-6 weeks of the event being cancelled. Ordered services that have already been provided, however, must be paid for.
